#### **Policy Statement:**

The College Dropout Management System (CDMS) Policy aims to establish guidelines and procedures for effectively managing college dropouts and supporting their academic progress and success. This policy outlines the responsibilities of relevant stakeholders, including faculty, advisors, administrators, and students, in identifying, monitoring, and providing necessary interventions to reduce dropout rates and enhance student retention.

# **CDMS Procedures:**
